Description of Activities

Field activities for implementation of the Groundwater Sampling and Analysis Plan (SAP) dated April 29, 2008 were completed during the month of November, 2008. Field activities completed include the following:

- Sampling of final groundwater monitor wells identified in the SAP.
- Installation, groundwater sampling, and plugging of the temporary river bank monitor points.
- Assembly and installation of diffuse samplers at potential seep locations along the Walnut River.
- Completion of pneumatic slug testing of groundwater monitor wells as identified in the SAP.
- Recovery of diffuse samplers and submittal of samples for analyses.
- Sampling of Walnut River surface water and surface soil at and adjacent to potential seep locations and temporary monitor points.

EPA forwarded draft comments on the HHRA Work Plan and River Bank Soil SAP on September 4, 2008. A response to comments was prepared and submitted during this reporting period and a meeting with EPA was requested for the first quarter of 2009 to discuss comment responses and finalize the Work Plan.

Summary of All Findings

A compilation of recent off-site groundwater data and data from sampling at the Walnut River will be prepared and submitted to EPA during the next quarter.
