This letter is offered as the report of investigation activities at the Former Augusta Refinery (FAR) in accordance with Section X, "Reporting," of the Administrative Order on Consent dated October 24, 2003, Docket No. RCRA-07-2004-0009. This report addresses activities occurring during the period of April 1 through June 30, 2014.

Description of Activities

- During the quarter, worked with Mr. Greg McCabe (EPA Risk Assessor) to resolve the Human Health Risk Assessment (HHRA) Addendum methods for evaluating the chromium IV data.
- During the weeks of April 7 and 14, 2014, completed 54 and plugged 41 of the existing two-inch temporary monitor wells in accordance with the EPA-approved Work Plan.
- On May 28, 2014, downloaded transducer data and collected water levels as part of the continued the Water Balance evaluation through monitoring of transducers per the September 11, 2013 scope of work.
- On June 2 and 3, 2014, gauged and bailed LNAPL from monitor wells as part of the continued the LNAPL evaluation per the September 11, 2013 scope of work.

The revised work plan included additional wells to be retained for completion as requested by the EPA and plugging of wells that were noted as damaged during the recent groundwater monitoring event.

- On May 19, 2014, CB&I submitted the SWMU 17 Additional Asphalt Stabilization Report to the KDHE.
- During the quarter, CB&I continued communications with EPA regarding the HHRA Addendum. On June 26, 2014 an agreement was reached with EPA regarding the evaluation methods for the chromium VI in the HHRA Addendum.
